PARADE RULES:

1. A signed release and Hold Harmless Agreement must be signed.
2. No registrations will be accepted after 4 pm on May 26, 2017
3. No alcoholic beverages are permitted. No vulgarity will be permitted. Participants and entries in the parade are not allowed to have or be under the influence of drugs or alcohol,
4. Tow and trailer length not to exceed 35 feet without written permission from parade officials.
5. Parade entries are to arrive for lineup early enough to be placed in the parade. It is not 1st come 1st served.
6. Parade Coordinators reserve the right to remove your entry from this parade for not abiding by the rules outlined above.

LIABILITY WAIVER FORM

Unconditional Waiver of Liability

By this act, I agree forever to release the Lake Whitney Freedom Fest and all its organizers, officers, directors and staff from any and all liability for any injury or harm I or any members of said organization including any minor child may suffer as a result of participation in said parade or activities preparatory or subsequent thereto. This act shall bind me, as well as my heirs, family and assigns.

Furthermore, this waiver and hold harmless shall apply in favor of the Lake Whitney Freedom Fest and all its organizers, officers, directors and staff, regardless of who might institute and claim or action arising from said parade or activities preparatory or subsequent thereto.
